Office of the Chief Medical Examiner (OCME) Statute

The office was formed back in 1971 under the guidance of the 11th Guam Legislature and approved by the people of Guam and then Governor Carlos G. Camacho.

It was established to provide a scientific investigative system for the island of Guam on deaths which occurred suddenly without cause or from unnatural circumstances.

The office is controlled by the *Commission on Post-mortem Examinations* which is made up of the Attorney General of Guam, the Guam Police Department Chief, Public Health & Social services Director, Guam Memorial Hospital Authority Administrator, the Guam Medical Society President, and the current Chief Medical Examiner. (Guam Code Annotated Title 10 Part 2 Division 4 Chapter 81)

In addition, OCME is guided by the Rules and Regulations formulated by the Commission on Post-mortem Examinations, Guam Code Annotated Title 10 §81102 & 81109 which were filed with the Guam Legislative Secretary on May 18, 1981 and for uniformity purpose a new numbering system was adopted and now known as 26 Guam Administrative Rules & Regulation (GAR) Division 3 Chapter 20.

MISSION

Our purpose is to determine a true cause and manner of death by conducting medico-legal death investigations, autopsies, toxicology & specimen analysis on all unnatural & unusual deaths, such as but not limited to homicides, suicides, accidents, sudden unexpected deaths that occurred in a suspicious manner or caused by an unrecognizable disease. In addition, postmortem examinations must also be done on individuals who expire outside of a hospital facility or less than 24 hours after admission to a hospital facility and whose body is to be shipped off island, cremated, or buried at sea. OCME provides support to Guam's public health and safety.

Initiatives & Community Benefits

- ✚ **Efficiently** perform Medico-Legal Death Investigations.
- ✚ **Accurately** establish a factual explanation of the evidence for every death investigation.
- ✚ **Increase** public awareness of the importance of a medico-legal death investigation.
- ✚ **Output** statistical reports and Medico-legal investigation results to the public through the local Medias.
- ✚ **Maintain** a Neutral and Non-biased interpretation of the evidence found during a medico-legal death investigation.

"The Chief Medical Examiner's office works to provide a reasonable explanation to the cause and manner of death for a deceased person based on the evidence obtained during a postmortem examination. We maintain that all interpretations of the evidence uncovered by the medico-legal death investigations are neutral by its nature."

DEFINITIONS:

- Postmortem Examination:** An examination of an individual after death for the purpose to determine a true cause and manner of death.
- Medico-legal Death Investigation:** The investigative process utilizing protocols & techniques to determine the cause and manner of death of a deceased individual by skilled practitioners' e.g. medical examiner, death investigator, police officer.
- Autopsy:** A surgical procedure performed by a licensed physician on a deceased person.
- Non-Autopsy:** A non-surgical external examination performed by a licensed physician on a deceased person.

Our Performance *(What We Have Been Doing)*

FY2015

OUTPUT: Postmortem examination results, certification of deaths, & exam reports are completed in a timely fashion. Annual statistical reports are prepared and submitted to Guam's Bureau of Statistics & Planning for their annual publication. In addition, monthly reports on Suicide cases are compiled and submitted to Guam Behavioral Health and Wellness Center for their Suicide Prevention Program. Other statistical reports on other death cases are prepared as requested by individual(s) or entity. Academic presentations are conducted to high school & post-secondary students, law enforcement, physicians, attorneys, etc. by the Medical Examiner upon request.

OCME has an active **Student Internship and Job Shadowing Program** for current post-secondary students studying in the fields of Criminal Justice, Law, Public Administration, Biology, Medicine, & Nursing. In 2015, OCME had six (06) student interns and two (02) job shadowing students from colleges on & off island. Student interns are tasked with an array of duties along with upfront exposure to postmortem examinations and medico-death investigation procedures. Under the job shadowing program, students observe the Chief Medical Examiner conduct postmortem examinations and any other duties he may perform.

In 2015, OCME conducted a total of 673 postmortem examinations and issued 674 Certification of Death reports. We also issued non-autopsy, autopsy, and/or toxicology reports, Verification of Death notices, and Certification of a Non-communicable Disease letters upon request at no cost to the recipients.

Of the 673 postmortem examinations conducted 405 deaths were those of the **MALE** gender. There were 592 postmortem examinations performed on deaths resulting from **NATURAL** causes. The top natural cause of death examined in 2015 was that of **HEART DISEASE** at 261 deaths of which 159 were of the male gender. The number two natural cause of death was **CANCER** at 101 deaths followed by lung, brain, liver, & kidney diseases, sepsis (bacterial infection), and so forth.

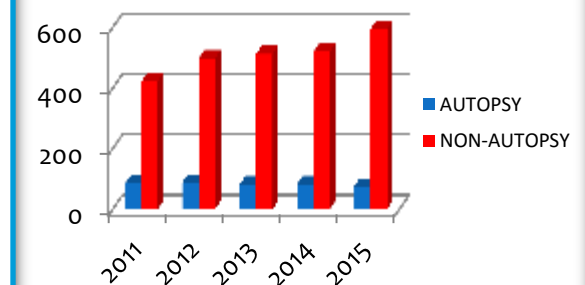

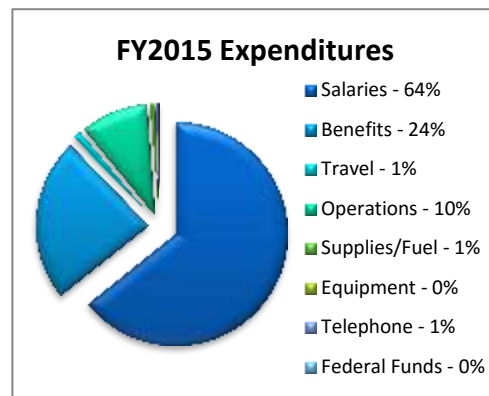

OCME's OPERATIONS:

- **Off-Island Travel and Professional Development cost:** Exclusively for the Medical Examiner for his yearly continuing education courses and membership fees as prescribed in his current employment Agreement.
- **Locum Tenens Contract:** Acting Medical Examiner professional services contract to cover the Medical Examiner during absence of more than three (03) days which is renewed every fiscal year averaging \$3,000 per year.
- **Memorandum of Understanding (MOU):** Intra-department work order between Guam Memorial Hospital Authority (GMHA) & OCME for services such as but not limited to power, water, laboratory, housekeeping, etc. renewed annually at \$36,000. Contract amount may change when cost of services increase by GMHA.

OCME has continued to spend within its total appropriated budget for both years and spend less than appropriated in an effort to decrease the government's deficit without jeopardizing the agency's mission. Budget approvals are appropriated non-itemized allowing the agency to handle where funding will be allocated throughout the year with direct supervision of the Bureau of Budget Management & Research (BBMR) and the approval of the Governor of Guam. In addition, there was a 15% Reserve (*Not allotted funding*) placed on agency's budget by BBMR in an effort to reduce the government's current deficit.

SIGNIFICANT VARIATION OF TOTAL APPROPRIATIONS TO ACTUAL EXPENDITURES

In FY2015, OCME spent 3% more than the previous year and managed to save \$5,424 from its total appropriations for the fiscal year. The 3% expenditure was for increases with Salary & Benefit of two staff, Travel airfare and per diem rates, & Operation expenses. No salary increase was received by the Medical Examiner or Acting Medical Examiner. In addition, there was no equipment acquired through the general funds for FY2015.

FEDERAL FUNDING

FY2015 FEDERAL GRANT AWARD: Federal grant awarded on March 19, 2015 from the U. S. Department of Interior (DOI), Office of Insular Affairs'(OIA) through their Maintenance Assistance Program (MAP) a federal grant of \$71,808.00 to acquire an agency specialized vehicle and for the upgrade of office & autopsy equipment. Federal Grant award will commence by FY2018.

*The last awarded federal grant was back in FY2004 for office and autopsy equipment funded by the U. S. Department of Interior (DOI), Office of Insular Affairs' (OIA) through the Compact of Free Association (COFA) funds. A few of the acquired office and autopsy equipment during this period are still being used however deteriorated.
